The City of East Lansing will hold a public hearing to hear public comments related to the 2019 Consolidated Annual Performance Evaluation Report (CAPER) which covers activities undertaken by the City of East Lansing through the Community Development Block Grant Program from 7/1/2019-6/30/2020 prior to its submission to the Department of Housing & Urban Development. However, this public hearing will only be held electronically pursuant to the Open Meetings Act, Act 267 of 1976, and the capacity restrictions and social distancing requirements set forth in the MDHHS Director's Emergency Orders. 1. **Reason for Electronic Public Hearing.** The City is holding this public hearing by electronic means only due to the restrictions imposed by the MDHHS Director's Emergency Orders. If the Orders are revised and if an in-person meeting is to be held instead of an electronic meeting, the meeting may be rescheduled to a different date and time. Notice of any such change will be posted at the City Hall and on the City's website.
