

# City of East Lansing One Pager Plus

## Important Ordinances

### Bulk Item Pickup

**Ord. 1300:** In an effort to create a cleaner and safer community, the East Lansing City Council approved an amended ordinance that allows for a shortened notification period for bulk item violations.

Bulk items include furniture, appliances, carpet, mattresses and other large rubbish items that exceed 40 pounds and/or do not fit in a 32-gallon yellow City trash bag. If these items are placed at the curb without a City sticker/scheduled pickup or on the wrong day, they are in violation of the City's amended litter/bulk item ordinance. Residents now have two hours to remove these items if they receive a face-to-face notification and eight hours to remove items if a violation notification is posted outside of their residence.

A citation can be issued if bulk items are not removed from the curb in these allotted time periods, resulting in fines (currently set by the court at \$220 for similar violations) and abatement costs (\$35 if removed during regular business hours or \$150 if removed after hours.) Removed items should be placed inside of the resident's house or garage until the appropriate scheduled pickup date. ### Fireworks

**Sec. 26-66:** Section 26-66 states that it is illegal to ignite, discharge or use consumer fireworks except after 11 a.m. on the following days:

- December 31 until 1 a.m. on January 1.
- The Saturday and Sunday immediately preceding Memorial Day until 11:45 p.m.
- June 29 to July 4 until 11:45 p.m. on each of those days.
- July 5, if that date is a Friday or Saturday, until 11:45 p.m.
- The Saturday and Sunday immediately preceding Labor Day until 11:45 p.m. on each of those days.

Consumer fireworks include sky rockets/bottle rockets, sky lanterns, firecrackers, roman candles and multiple rocket launchers. Consumer fireworks do NOT include "low impact fireworks" such as handheld and ground-based sparklers and fountains or "novelties" such as smoke bombs, party poppers, snakes and caps. **Igniting consumer fireworks during time periods not allowed by the city code is a civil infraction with a fine of \$1,000 for each violation.**

### Party Litter Ordinance

**Ord. 1260:** City Council adopted a revised party litter ordinance, which includes a provision that will allow Parking & Code Enforcement (PACE) officers to issue a ticket without issuing a prior warning.

A tiered fine system allows PACE to fine \$130 for the first offense, \$180 for the second offense, \$280 for the third offense and \$480 for the fourth. Terms and conditions can be imposed upon a rental license if there are five or more citations issued within a 12-month period no matter what the violation. Additional costs may be charged if the party is declared a nuisance gathering and intervention is required.



## Important Ordinances (Continued)

Warnings will still be issued for minor offenses and PACE officers retain discretion to simply issue warnings rather than tickets. The no-warning ticket will be reserved for addressing egregious offenses, as well as properties where repeated offenses occur.

### Snow and Ice Removal

**Ord. 1326:** Snow that accumulates before noon on a sidewalk must be cleared by midnight the same day and snow that accumulates after noon on a sidewalk must be cleared by midnight of the following day. For snow showers that occur on more than one consecutive day, snow must be cleared by the above stated times or within 48 hours after the first snowfall began, whichever is sooner. Ice should be cleared or an abrasive (salt, sand, etc.) should be applied within 12 hours of formation. Keep these things in mind when going home for winter break. You are responsible for making sure the sidewalk next to your property is maintained and clear enough for everyone to use, including those in wheelchairs. Currently, the 54B District Court assesses \$85 in fines and costs. Please note, fines and costs are determined, in part, by legislative requirements. ### Open Alcohol Ordinance

**Sec. 26-52:** Prohibits the possession of any alcoholic beverage in an open container or container with a broken seal in any public place or private area open to the public except a licensed liquor establishment or elsewhere as provided by ordinance.

### Disorderly Conduct Ordinance

**Sec 26-52:** Prohibits the following:

- **Remaining within 300 feet of a fire:** No person shall be or remain on public property or the unenclosed private property of another within 300 feet of a structure fire, vehicle fire or open fire, except persons attempting to put out or contain the fire.
- **Public Intoxication:** No person shall be intoxicated in a public place and be endangering directly the safety of another person or property.
- **Public Urination:** No person shall urinate, defecate or spit on any street, sidewalk, alley, park, parkway, parking lot or structure, public carrier or upon any public property.
- **Engaging in a Riot:** No person shall assemble or act in concert with four or more other persons for the purpose of engaging in conduct constituting the crime of riot, including the destruction of public or private property, throwing objects, starting a fire, etc.

### Minor in Possession (MIP) Ordinance

**Sec. 26-53:** It is illegal for anyone under the age of 21 to consume alcohol. Any person suspected of being a Minor in Possession of alcohol will be required to show proof of age and may be asked to take a breath alcohol test.

### Noise Ordinance

**Sec. 26-81:** Prohibits noise which may disturb neighbors. Examples are stereos played at loud levels

and inappropriate shouting at any time. After 11 p.m., the noise violation will be written as a misdemeanor offense. Your landlord will be notified of any noise violations.

### Enhanced Party Noise Ordinance

The amendment defines enhanced party noise as a violation of the noise ordinance and two or more of the following conditions:

- A common source of alcohol used to serve the guests, such as a keg
- A live band or disc jockey or other live entertainment
- A charge to gain entrance into the residence or to consume alcohol
- Amplified sound emanating from speakers placed or directed outside of the building
- Outdoor drinking games where alcohol is involved

### Trash

**Sec. 36-85:** Trash goes out at 8 p.m. the night before pickup. Trash containers should be brought in by 10 a.m. the following day. Trash containers must be stored at the rear of the house if stored outside.

### Parking

**Sec. 50-814:** No parking on any residential street from 12 a.m. to 6 a.m. No parking on all other streets from 2 a.m. to 6 a.m. No parking in yards.

### Grass Height

**Sec. 302.4:** Maintain a presentable yard. Grass cannot exceed six inches.

### Outdoor Furniture

Do not leave indoor furniture outdoors.

### Swimming Pools

**Sec. 303.1:** No pool, swimming pool, hot tub or spa of any depth—permanent or temporary—shall be placed in the front yard or side yard (unless enclosed) of any one-family, two-family or multiple-family dwelling.

### Yard Waste Disposal

**Ord. 1324:** No person shall place lawn clippings, leaves or other yard waste in any park. No person shall deposit yard waste in any alley, street, river or other public place except for collection by the City. No person shall deposit leaves in any street except when the City's fall bulk leaf collection is in effect. No person shall deposit any yard waste in any public drain. No person shall deposit yard waste in any public drain easement that will result in the waste entering the drain or otherwise interfering with the proper operation of the drain.
